

MarkeTouch Media, Inc.
Do Not Call List Information
(Updated 8/18/06)

The delivery of recorded messages is regulated by both National and State agencies. The regulations include (among others) restrictions on what type of calls may be made, and when callers must honor Do-Not-Call lists. It is the client's responsibility to be knowledgeable of and comply with all regulations.

This document does not provide legal guidance, but describes which Do-Not-Call lists are available from MarkeTouch Media. Clients may instruct MarkeTouch Media how to configure their mailboxes to use or not use the available lists by completing a "Compliance Worksheet" available from customer service at 800-840-8111.

The National Do-Not-Call (DNC) List: MarkeTouch Media has acquired the list. Tax-exempt and political customers may elect to have MarkeTouch Media apply the National DNC List to their mailboxes. All other customers may request the National DNC List by providing their FTC Subscription Account Number.

States Using National DNC List: The following states have Do-Not-Call regulations that use the National DNC list. Customers that are required or desire to apply these lists must request the National DNC list as described above.

States Specific Lists - Available: The following states have Do-Not-Call regulations and maintain their own Do-Not-Call lists. MarkeTouch Media maintains these lists in a global State Do-Not-Call List. Customers may request that their mailboxes apply this list automatically.
